key responsibilities

Fundraising and Impact Coordination

- Work with board, committee members, staff, and volunteers to organize fundraising events
- Work closely with Creative Manager on event marketing and design materials
- Collaborate with Creative Manager and Senior Director of Advancement on virtual/online fundraiser strategies and execution
- Coordinate additional community or donor-focused events, dinners, or receptions
- Monitor progress of fundraising events through data collection and tracking systems
- Evaluate performance of fundraising efforts to determine the most effective course of action
- Recruit sponsors, participants, or volunteers for fundraising events
- Identify, build relationships, and secure commitments of participation or donation from individuals or business donors
- Coordinate business fundraisers in the community
- Assist the Senior Director of Advancement at public speaking engagements, tabling, and community events

In-Kind Donation Coordination

- Assist with the solicitation and general management of all in-kind donations
- Solicit donations from corporations, foundations, and community partners
- Cross department collaborate with direct service staff on donation related needs of clients
- Distribute such donations throughout the agency as needed, based on the needs of our clients
- Coordinate pick-up and drop-off times for in-kind donations
- Communicate professionally and clearly with donors to explain needs and requirements regarding the donation process
- Effectively use an inventory tracking system to keep donations organized

- Partner with our VISTA team member to recruit, organize, and oversee volunteer projects that promote involvement and investment in the organization

Minimum Qualifications

- Two years' experience with coordinating community centered fundraising, including fundraising events
- Must be 21 years of age or older
- Knowledge of Microsoft Office software including Word, Excel, Access, Outlook, Publisher
- Knowledge of professional use of social media platforms, including Facebook, Twitter, and Instagram
- Careful attention to detail and strong organizational skills
- Ability to work in a fast-paced environment, manage many different ongoing projects and meet deadlines
- Excellent written and interpersonal communication skills
- Strong presentation skills and ability to communicate effectively with diverse audiences

Required within first 30 days of employment:

- CPR/First Aid/Bloodborne pathogens certifications required
- Must have a negative TB test
- Full understanding of the CPS reporting requirements
